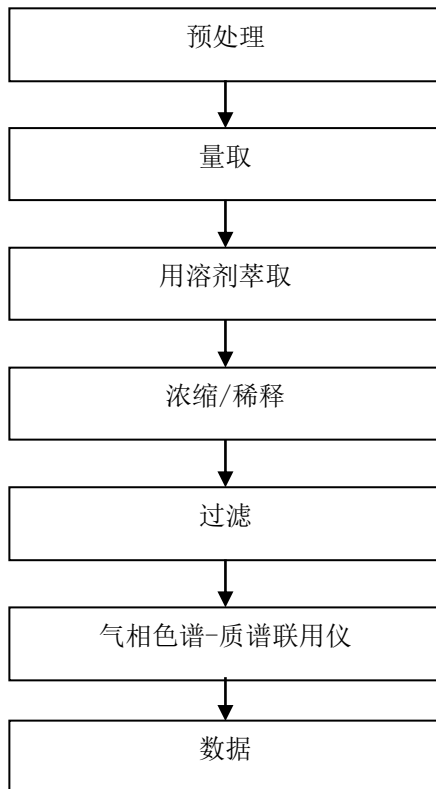

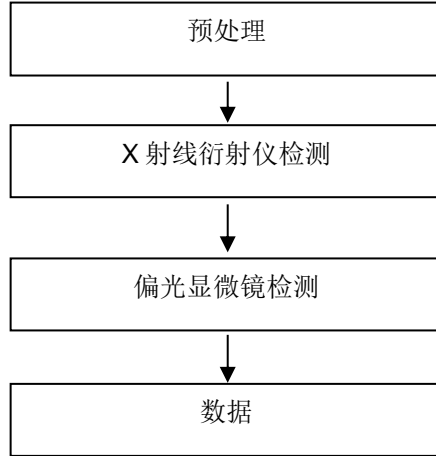

Asbestos 检测流程图



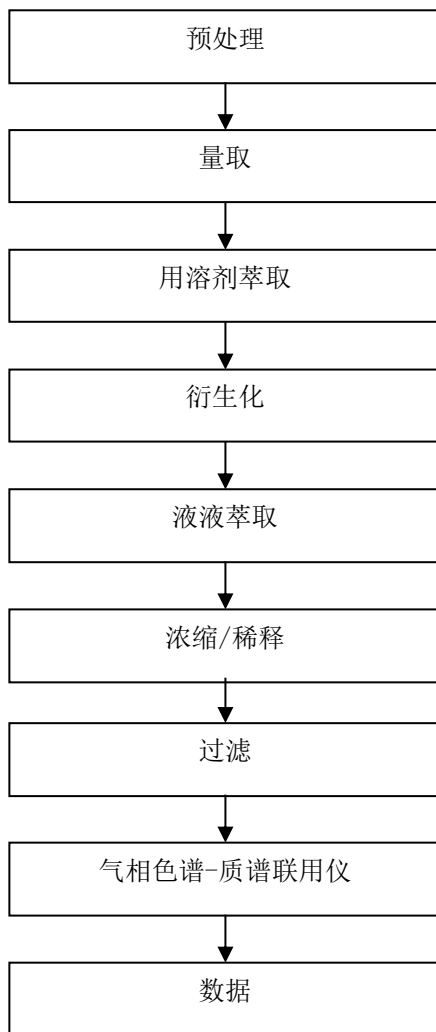

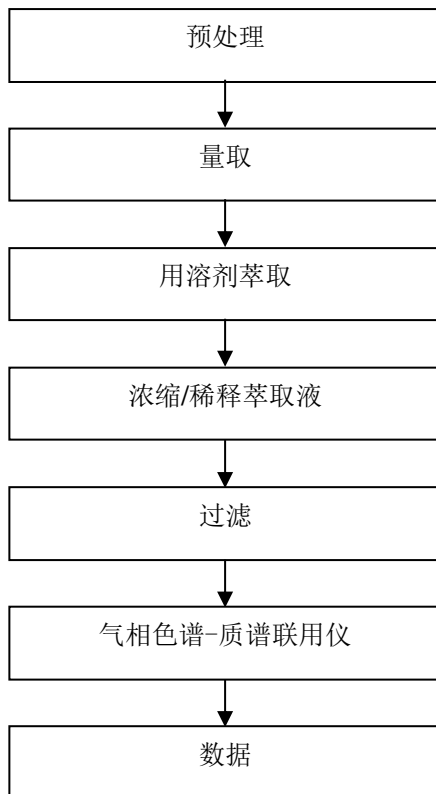
